We hereby submit specifications and estimates for:

Proposal to tear off existing shingles down to roof sheathing. Inspect and replace rotten wood, up to three 4x8 included, thereafter \$0.00 per sheet installed. Furnish and install Atlas Pinnacle Pristine lifetime shingles with 3M Scotchguard lifetime algae resistance installed with 1 ¼” nails over Titanium UDL-30 synthetic underlayment. Furnish and install Shingle Vent II ridge vent. Furnish and install drip edge. Furnish and install ice and water shield to all valleys, eaves and penetrations. Replace all flashings. Replace plumbing flanges and install PermaBoot advanced flashing system. Clean out gutters.

Proposal Cost: \$0.00

Clean up and haul away all job related trash. Survey area with magnets. Manufacturer warranty on all materials. Labor warranty **five** years. Not responsible for nail pops, high rafters, sunken plywood or any other existing structural damage. Not responsible for satellite dish signal. Chimneys 30 years of age or older should be properly inspected by a Mason prior to roof installation for warranty.

Deposit of 1/3 due upon acceptance, remainder to be paid upon completion.

Material is guaranteed to be as specified. All work is to be completed in a workmanship manner according to standard practices. Any alteration or deviation from above specifications involving extra cost will be executed only upon written order and will be an extra charge over and above estimate. No agreement between customers and our workmen will be recognized as part of this contract. Title to all equipment and materials used on this installation will remain with Tayman Roofing & Siding, Inc. until all sums due Tayman Roofing & Siding, Inc. under this contract are paid. Our agreements contingent upon strikes, accidents, acts of God or delays beyond our control. Our workers are fully covered by Workmen Compensation Insurance.

The parties agree that this contract will be fully paid upon completion; however, if the purchaser shall not pay upon completion as agreed, a service charge of 1.5% per month on the unpaid balance will be added and the purchaser agrees to pay such service charge until the remaining balance is fully paid. (ANNUAL PERCENTAGE RATE – 18%) purchaser agrees to pay attorney fees of 25% of the unpaid principal balance in the event the account is referred to an attorney for collection. This paragraph is void if financing is selected.
